Before you go, don't forget to submit a travel notice — you can do this easily through our mobile banking app, submitting a notice at www.dpfcu.org, or by calling or texting us. This helps DoverPhila keep your account secure and avoid any interruptions in card access.

Need to access your account while you're away? With Shared Branching, you can visit thousands of credit union branches nationwide for in-person service. Just bring your photo ID and use CO-OP IDCheck to securely complete transactions at out-of-state Shared Branching locations. Plus, over 30,000 Shared Branching ATMs are available nationwide (117 ATMs internationally) for convenient cash access without the fees.

Stay a step ahead of fraud by using Debit Card Controls in the DoverPhila mobile app to monitor transactions and manage your card settings in real time.

CHANGES TO FUNDS AVAILABILITY EFFECTIVE JUNE 30, 2025

The following changes to our Funds Availability Policy will take effect June 30, 2025:

1. The minimum amount of deposited funds that credit unions must make available for withdrawal by opening of business on the next day for certain check deposits is \$275 (up from the current \$225);
2. The amount of funds deposited by certain checks in a new account that are subject to next-day availability is \$6,725 (up from the current \$5,525);
3. The threshold for using an exception to the funds-availability schedule if the aggregate amount of checks on any one banking day exceed the threshold amount is \$6,725 (up from \$5,525);

All holds listed are business days following the banking day of deposit. Please contact us with any questions or to receive a copy of our current Funds Availability schedule in its entirety.
